#### SCHOLARSHIP ELIGIBILITY CRITERIA

- 1) Applicants can be a male or female
- 2) Applicant must be a graduating high school senior or an undergraduate student enrolled at an accredited college, university, trade school, or religious institution.
- 3) Applicant must submit a copy of their high school or recent college transcript.
- 4) Applicant must have a 2.8 cumulative grade point average (on a 4.0 scale).
- 5) Applicant must be enrolled in a 2 or 4 year program.
- 6) Applicant must provide a typed statement not to exceed one (1) page indicating why you intend to pursue a higher education.
- 7) Applicant (High school applicant) must be a graduate from any Columbia or Hamilton County high school (public or private).
- 8) Applicant must provide three (3) letters of recommendations, one (1) from a pastor or community leader, one (1) from an educator and one (1) from an adult or older peer who has served as a role model for the student.

The Scholarship Committee will base their preliminary decision for student approval on the fulfillment of criteria in items 1 through 8. The committee will then rate the applicants on a scale of 1 through 5 on the criteria described in item 8. Those who have an average rating of 4 or 5 on the criteria will be considered as finalist for scholarships.
