RULES GOVERNING AUTO/ON CAMPUS DRIVING PRIVILEGES

Every car parked in the student and faculty parking lots must have appropriate parking decal displayed on the interior front dash windshield, driver's side. Annual cost of the auto parking permit is \$7.00. The parking permit is not transferrable and must be posted on the rear view mirror at all times while on the premises. Cars must be parked in designated parking spaces ONLY. Student parking is restricted to the student parking lot area. Students may NOT park in the designated staff parking spaces; front parking lot of High School, or the District Office Parking Lot. The School must have a copy of your current auto insurance on file.

In addition to the safe and courteous driving skills taught in Driver's Ed, the following rules are mandatory per the student code of conduct: To include parking in unauthorized areas, driving or parking without proper sticker, improper driving on campus, or unauthorized driver on campus.

PENALTIES FOR DRIVING OR PARKING INFRACTIONS:

1. FIRST OFFENSE, REFERRAL TO SRO.
2. SECOND OFFENSE, \$10 FINE AND SUSPENSION OF DRIVING PRIVILEGES UNTIL FINE IS PAID.
3. THIRD OFFENSE, \$15 FINE AND SUSPENSION OF DRIVING PRIVILEGES FOR 45 DAYS.
4. REPEATED, \$20 FINE AND SUSPENSION OF DRIVING PRIVILEGES FOR 45 DAYS TO REST OF SCHOOL YEAR.
